- Each restricted stock unit ("RSU") represents a contingent right to receive one share of the Issuer's common stock.
- 263,514 restricted stock units ("RSUs") were granted on September 30, 2019, with 131,756 vesting prior to the date of this Form 3. The remaining 131,758 RSUs vest as follows: 65,879 on April 29, 2022 and April 29, 2023. Settlement of vested RSUs will occur within 60 days of the applicable vesting date.
- 894,663 restricted stock units ("RSUs") were granted on March 31, 2020, with 223,665 RSUs vesting prior to the date of this Form 3. The remaining 670,998 RSUs vest as follows: 223,666 on March 31, 2022, March 31, 2023 and March 31, 2024. Settlement of vested RSUs will occur within 60 days of the applicable vesting date.
- The restricted stock units ("RSUs") were granted on March 23, 2021 and vest as follows: 85,663 on March 23, 2022, March 23, 2023, March 23, 2024, and March 23, 2025. Settlement of vested RSUs will occur within 60 days of the applicable vesting date.
- The performance stock units ("PSUs") were granted on April 29, 2019. Each PSU represents a contingent right to receive one share of the Issuer's common stock. The PSUs vest upon the Issuer's common stock achieving a specific price per share.
